

## Pre-Arrest Diversion Verification Tool

The Civil Citation Network integrates law enforcement, clinical support services and partner stakeholders for straightforward management of citations.

The Adult Pre-Arrest Diversion Program (APAD) initially implemented in Leon County, Florida is a public/private self-sustained pre-arrest diversion program. Success of the program rests with law enforcement officers issuing citations that incorporate evidence-based assessments and appropriate intervention services. Health providers assist in support services with a clear goal of reducing recidivism.

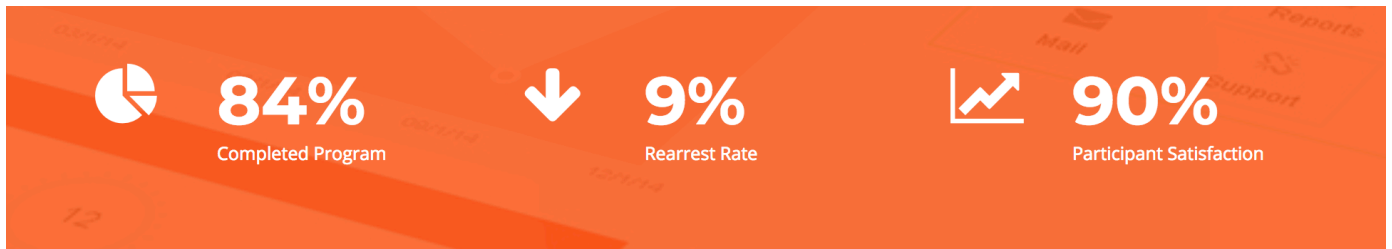
Intervening at the earliest point in the process is critical. The Network deploys a set of tools to hold the adult/juvenile accountable throughout the process. This is accomplished through the Network's proprietary software platform that seamlessly blends law enforcement, clinicians and appropriate stakeholders. The software allows agencies complete management without the headaches of servers, software, paper management and dedicated IT staff. All this in a secure and encrypted environment.

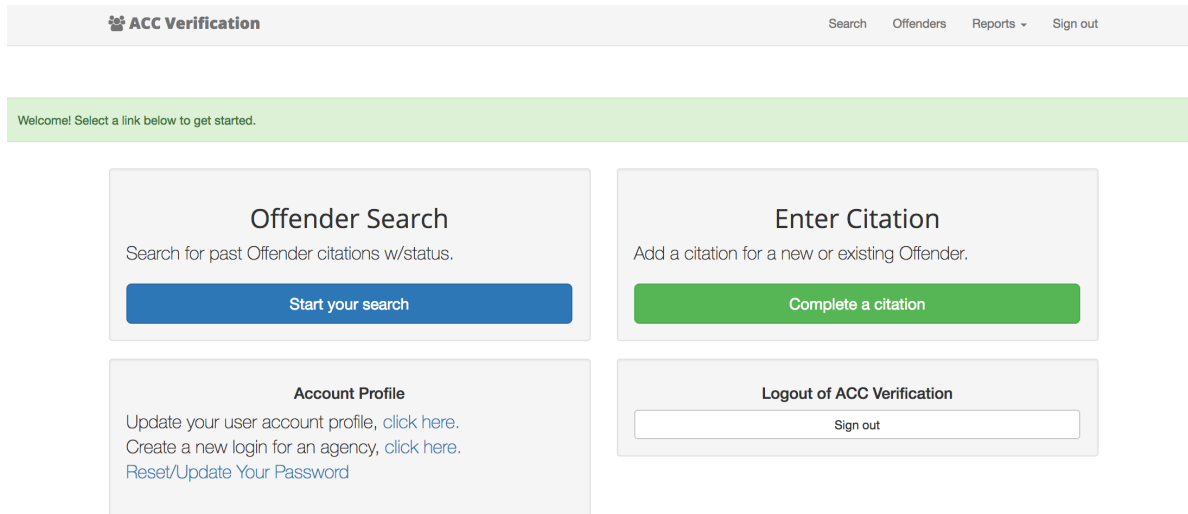

## Adult & Juvenile Verification Services

The Network offers municipalities and stakeholders a mechanism to determine eligibility - in real-time. The Network has created a proprietary web-based software allowing LEO's to search a national civil citation database of offenders. The verification tool allows each municipality to follow their implemented ordinance and in less than a minute determine if the offender's eligibility meets those guidelines. A few screenshots of the search and results follow:

After logging in LEO's or stakeholder partners have the capability to search or enter data into the nation-wide database of offenders.
